Program Overview:

This CDC-recognized lifestyle change programs run for 1 year. In the first 6 months, your patients will meet weekly for 1 hour to learn to:

- Eat healthy without giving up all the foods they love
- Add physical activity into their busy schedules
- Deal with stress
- Cope with challenges that can derail their hard work—like how to choose healthy food when eating out
- Get back on track if they stray from their plan—because everyone slips now and then

In the second 6 months, they will meet monthly for 1 hour to build on the skills they've learned and maintain their positive changes. They will review key concepts such as setting goals, tracking food and physical activity. staying

motivated, and overcoming barriers. The second 6 months is essential to help your patients stick with new habits.

Renown Health's Institute for Cancer should be your go to for radiation therapy referrals. Renown Health is in-network for all Hometown Health and Senior Care Plus members and the Institute for Cancer utilizes the state-of-the-art Varian TrueBeam radiation therapy system.

The TrueBeam system delivers treatment so precisely, it reaches sub-millimeter levels of accuracy, and unlike other treatment centers in the region, Renown has the technology to deliver radiation from 360 degrees around the patient's body. This targets cancerous cells while sparing healthy tissue.

Please note, CyberKnife referrals will no longer be considered in-network except for a diagnosis of trigeminal neuralgia. Patients requiring radiation therapy should be referred to Renown Oncology. Most patients will receive appointments within two days.

Program Efficacy:

The CDC supports this lifestyle change program because research shows it works. Over the course of 1 year, CDC-recognized lifestyle change programs offer about 24 hours of instruction to lower your patients' risk of type 2 diabetes **by more than half.**

A randomized, controlled clinical trial showed that completing this lifestyle change program reduced program participants' chances of developing type 2 diabetes by 58% compared to placebo (71% for individuals aged 60 and older), nearly twice as much as the reduction among the group taking metformin (31%).

This program focuses on life-long changes to certain

habits and behaviors, which helps participants maintain healthy improvements over time. A 10-year follow-up study icon showed that participants were still one-third less likely to develop type 2 diabetes a decade later than individuals who took a placebo. Those who did develop type 2 diabetes delayed the onset of the disease by about 4 years.

Program Eligibility:

To be eligible for this program, members must:

- Be at least 18 years old and
- Be overweight (Body Mass Index ≥25) and
- Have no previous diagnosis of type 1 or type 2 diabetes and
- Have a blood test result in the prediabetes range within the past year:
- o Hemoglobin A1C: 5.7-6.4% or
- o Fasting plasma glucose: 100-125 mg/dL or
- o Two-hour plasma glucose (after a 75 gm glucose load): 140–199 mg/dL or
- Take the Prediabetes Risk Test and receive a screening result of high risk for type 2 diabetes

Pharmacy Focus

New Medication Adherence Program

Adherence is an active choice of patients to follow through with the prescribed treatment while taking responsibility for their own well-being. Compliance is a passive behavior in which a patient is following a list of instructions from the provider.

When health conditions, such as diabetes, blood pressure and high cholesterol, are not well-controlled, patients can end up with additional problems or in the hospital. Senior Care Plus is committed to making sure our members are adherent with their medications. In order to help ensure adherence is as easy as possible for our members, Senior Care Plus has a new 100-day supply program. We are offering our members a 100-day supply at the 90-day supply co-pay. We hope this will encourage our members to stay adherent to their medications.

This program only applies to the medication categories below:

- Oral Diabetes Agents & Non-Insulin Injectables (Trulicity, Victoza, Ozempic)
- Blood Pressure Drugs (ACEs/ARBs/DRIs only)
- High Cholesterol Drugs (Statins)

What does this mean for your office?

You may have already received a fax request to switch your patients over to a 100-day supply. If you do not wish to prescribe a 100-day supply due to certain treatment plan circumstances, you can reach out to MedImpact at **(888) 586-8144** to have an override placed for less than a 100-day supply of medication. Medications in these categories will reject at the pharmacy if they are submitted for any day supply less than a 100 day supply.

We do encourage you to prescribe 100 days' supplies to increase medication adherence for our Senior Care Plus members.
